CORSIA Activities

- From 1 January 2019...
 - All aeroplane operators conducting international flights are required to monitor the CO₂ emissions from these flights
 - Information compiled by aeroplane operators in the corresponding annual Emissions Report (ER) is subject to third-party verification

- Aeroplane operators to report their 2019 CO₂ emissions to their States:
 - 31 May 2020: deadline for operators' submission to States
- States to report to ICAO:
 - 31 August 2020: States to submit to ICAO their aggregate 2019 CO₂ emissions data per State pair through the CORSIA Central Registry (CCR)

CORSIA baseline = Average of 2019 and 2020 emissions



Seminar objectives

 Provide information to CORSIA Focal Points on how to use the main functionalities of the CCR

• Facilitate a more productive face-to-face training during the Seminars when they happen later this year.

- Focus areas:
 - Introduction to the CCR
 - General familiarization with the CCR web interface
 - How to upload CO₂ emissions into the CCR
 - Submit CO₂ emissions to ICAO


